**REQUEST FOR APPROVAL OF LAND ALLOCATION IN MBALE FOR THE  
CONSTRUCTION OF THE PUBLIC PROCUREMENT AND DISPOSAL OF PUBLIC  
ASSETS AUTHORITY (PPDA) REGIONAL OFFICE**

The Public Procurement and Disposal of Public Assets Act 1 of 2003 established the Public Procurement and Disposal of Public Assets Authority (PPDA), as the principal regulatory body overseeing public procurement and disposal of public assets in Uganda. Recent amendments to the PPDA law have introduced several key changes, notably enhancing the Authority's regulatory mandate.

PPDA is dedicated to improving fiscal governance and improving the delivery of public procurement services across the region. Our focus is on fostering collaboration and innovation to better serve our constituents and stakeholders. We were allocated land in Mbarara and have commissioned a new office at Plot 2 Western By-Pass Link, Kamukuzi Division, Mbarara City.

We applied for land to establish a regional office in Mbale and received confirmation from the District Executive Committee of Council that suitable titled land is available. (See attached Annexures)
