**RE: CIRCULAR ON CHANGE OF ELECTRONIC SITE FOR THE
REGISTRATION OF PROVIDERS TO THE ELECTRONIC
GOVERNMENT PROCUREMENT SYSTEM No. 5 of 2021**

Reference is made to the above subject.

In accordance with Section 7(1)(h) of the PPDA Act, 2003, the Authority is mandated to maintain a register of providers of works, services and supplies.

As part of the reforms to make the public procurement system more efficient and accountable, the Authority is in final roll out preparations of undertaking procurement and disposal processes using the Electronic Government Procurement (eGP) System.

To this end, the registration of providers being undertaken at www.ppdaproviders.go.ug shall with effect from **15th July 2021** be redirected at <https://egpuganda.go.ug/> which is the electronic site for the eGP System.

This is to inform you of the above changes and to request that the Procurement and Disposal Units guide providers that all new registrations and/or renewals shall be on the eGP System site. Providers should use the "Register as a Supplier" and the "supplier registration guide" on the homepage for registration and guidance. The Registration of Providers (ROP) Certificate shall be issued online for printing by the provider off the system.

Under the eGP System, you shall be able to validate a providers' ROP certificates by searching for the provider's name under the "Suppliers" tab. You shall be able to verify whether a provider is under suspension by the Authority under the same tab.
