**ISSUANCE OF AMENDED STANDARD BIDDING DOCUMENTS, 2025- CIRCULAR
NO. 6 OF 2025**

Reference is made to the above subject.

Section 8 (1) (d) of the PPDA Act Cap 205 mandates the Authority to prepare, update and issue authorised versions of Standard Bidding Documents (SBDs), procedural forms and any other attendant documents to Procuring and Disposing Entities (PDEs).

Following the amendment of the PPDA Act, Cap 205 and the various PPDA Regulations, the Authority revised the following SBDs and their respective User Guides to align them to the provisions of the PPDA law:

- i. Procurement of Works under Open/Restricted Bidding Methods;
- ii. Procurement of Works under Quotation Method;
- iii. Procurement of Supplies under Open/Restricted Bidding Methods;
- iv. Procurement for Supplies under Quotation Method;
- v. Procurement of Consultancy Services under Open/Restricted Bidding Methods;
- vi. Procurement of Consultancy Services under Quotation Method;
- vii. Procurement of Non-Consultancy Services under Open/Restricted Bidding Methods; and
- viii. Procurement of Non-Consultancy Services under Quotation Method.

In accordance with Section 8(1) (d) of the PPDA Act Cap 205, the Authority guides all PDEs that the commencement date for the above amended Standard Bidding Documents is 8th September 2025.


